## Token Fest Sponsorship Contract Terms

**CANCELLATION:** (a) In the event the Sponsor cancels all or part of the Sponsorship contracted, for hereunder, the following provisions shall apply: cancellations received prior to December 15th, 2017 for Token Fest San Francisco are subject to a 50% cancellation fee, 100% cancellation fee applies after January 15th, 2018. Cancellations received prior to June 15th, 2018 for Token Fest Boston are subject to a 50% cancellation fee, 100% cancellation fee applies after July 15th, 2018. Whenever any sponsor or cancellation fee payable by Sponsor here under shall exceed the amount then held by Sponsor, Sponsor shall promptly pay to Token Fest, LLC the balance of such fee.

Sums payable by Sponsor hereunder shall be retained or received by Sponsor as liquidated damages (Cancellation Fee) and not as penalty. Sponsor shall not require payment of, and shall refund any payments for, the rental fee applicable to the cancelled sponsor space in excess of the Cancellation Fee payable hereunder. Any refunds due the Sponsor as a result of the cancellation of this contract will be made immediately after the event. (b) If exhibit space is not occupied by the Sponsor when the exhibit hall opens on the first day of the conference, Sponsor shall be deemed to have cancelled the sponsorship contracted for, and Sponsor shall waive the right to use such space as it deems appropriate, and the Sponsor shall pay Token Fest, LLC all amounts that would have been due under the terms of subparagraph (a). (c) If Sponsor does not make full payment of any sponsor fee when due under the terms of this contract, Token Fest, LLC may terminate this contract, and the Sponsor shall be responsible for payment to Token Fest, LLC for all amounts that would have been due to Token Fest, LLC under the terms of subparagraph (a).

Except as Sponsors rental obligation may be reduced in accordance with the terms set forth in subparagraph (a) above, the Sponsor shall be responsible for payment of the total sponsor space rental fee whether the Conference and Exposition is cancelled, delayed, or relocated, in whole or in parts, as a result of riot, strike, civil disorder, act of war, act of God, or any other cause of any kind whatsoever not within the Sponsor's or Token Fest, LLC's control; or rescheduled or relocated at the behest of the Sponsor. Use of Sponsor Space: All demonstrations or other promotional activities must be confined to the limits of sponsor space. Sufficient space must be provided for the comfort and safety of persons watching demonstrations and other promotional activities.

Each Sponsor is responsible for keeping their exhibit space free of congestion caused by demonstrations or other promotions. Except in certain limited circumstances involving parent corporations, their wholly owned subsidiaries, and sister corporations, when approved by Sponsor, Sponsor shall not assign, sublet, or share the space allotted without the knowledge and written consent of the Sponsor. Sponsors must display only the goods manufactured or dealt in by them in their regular course of business. No firm or organization not assigned sponsor space will be permitted to solicit business within the designated sponsor area for the event.

Token Fest, LLC reserves the right to restrict sponsor areas that because of noise, method of operation, materials or for any other reason become objectionable, and also to prohibit or remove any sponsor station that, in the opinion of the Token Fest management company, may detract from the general character of the Exposition as a whole or consists of products or services inconsistent with the purpose of the event. This reservation includes persons, things, conduct, printed matter, or anything of a character that the Sponsor determines is objectionable. In the event of such restriction or removal, the Sponsor shall not be liable for any refunds or other exhibit expenses. No animals may be offered as a part of the exhibit. The use of sound systems is permissible, provided they are audible not more than 3 feet into the aisle or neighboring spaces and the sound is directed in the exhibitors exhibit space or vertically. Token Fest, LLC shall have absolute control over the implementation of this regulation, the intent of which is that sound systems shall not be audibly objectionable to neighboring Sponsor stations.

**TAXES AND LICENSES:** Sponsor shall be responsible for obtaining any licenses, permits or approvals required under local or state law applicable to their activity at the Event. Sponsor shall be responsible for obtaining any tax identification numbers and paying all taxes, license fees or other charges that shall become due to any governmental authority in connection with their activity at the event. **Sponsor Safety:** Sponsor accepts responsibility for any personal or property damage that may result directly or indirectly from the collapse of its sponsor area or any portion thereof or the existence of any other unsafe condition at the designated sponsor area, including exhibit booth setup and breakdown.

**INTELLECTUAL PROPERTY:** Sponsor's name or logo may not be used without the express written consent of Sponsor, except as contemplated by this Event Sponsorship Contract and the associated Sponsorship Prospectus. Sponsor retains all rights to its intellectual property, including any logos, brands, letterhead and related branded materials.
